A portion of a county road encroaches over a corner of Lot 20 at Laupahoehoe Homesteads (TMK: 3-6-06: 13). The total area of the property, owned by the Robert L. Giuliani Trust, is 14.89 acres and zoning is Ag-20.


In resolving the encroachment problem, Deputy Corporation Counsel Gerald Takase arranged an agreement with the owner. Corporation Counsel acknowledges the Giuliani property presently contains two separate lots. The major parcel (approximately 14.78 acres) is mauka of the County road with a less than 0.1 acre parcel makai of the road. The County agreed to subdivide Lot 20 into a roadway parcel (Lot 20-C), which the trust will donate to the County, and two remaining equally-sized parcels (Lots 20-A and 20-B).

The attached map copies show the proposed subdivision. We request final approval of the subdivision plat.
