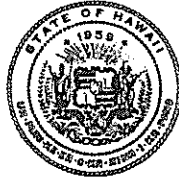

Subject: **Zoning for Kaniohale at the Villages of La'i`opua**

In accord with Section III provisions in the 2002 Memorandum of Agreement (MOA) between the County of Hawaii and the Department of Hawaiian Home Lands, the zoning district selected for parcels within the **Kaniohale at the Villages of La'i`opua, Phase I and Phase II** subdivisions is **RS-7.5** (single-family residential, minimum building site area of 7,500 square feet).

Included within this RS-7.5 designation are parcels within Third Division Tax Map Plats 7-4-22 and 7-4-23. Copies of these plat maps are enclosed.

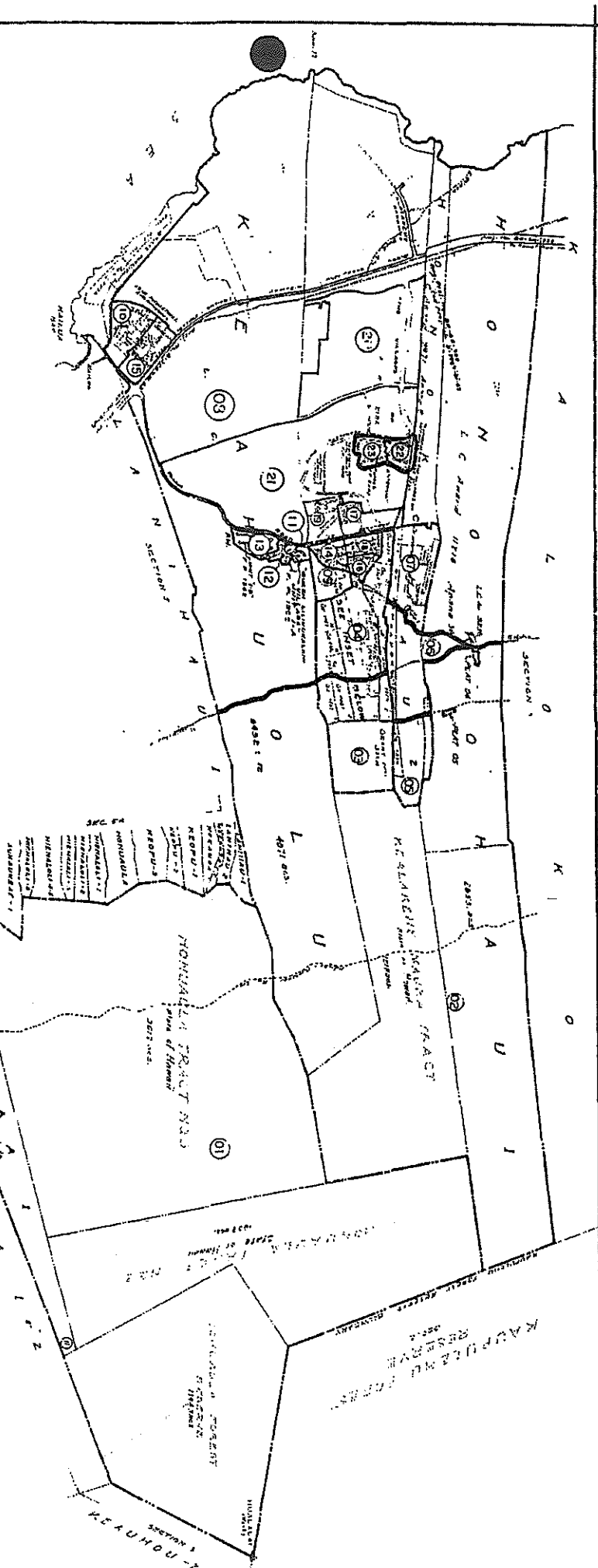
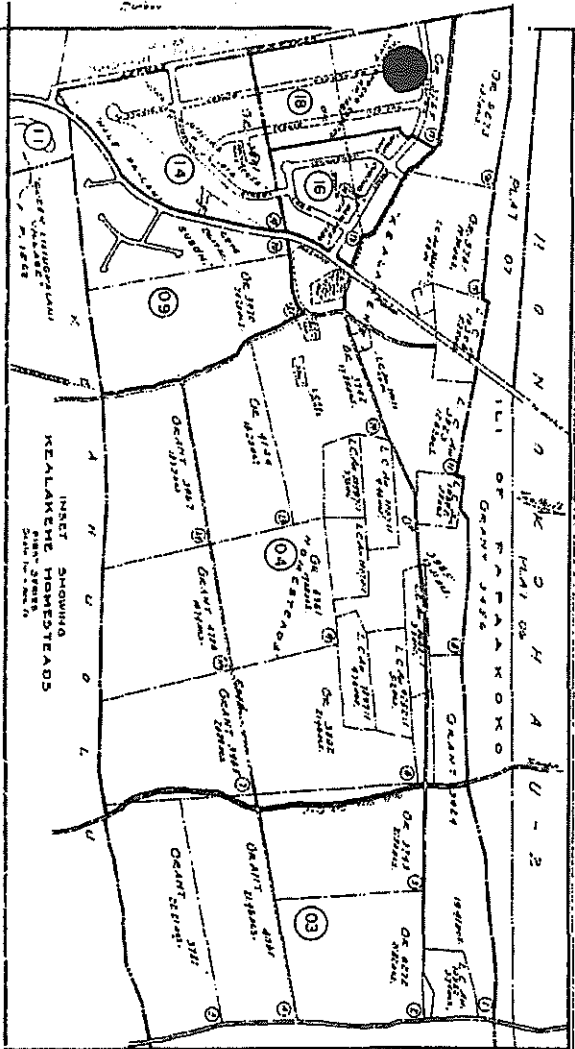
