In accord with Section III. provisions in the 2002 Memorandum of Agreement (MOA) between the County of Hawaii and the Department of Hawaiian Home Lands, the zoning district selected for parcels within the **Kawaihae 1st Residence Lots - Unit 1** subdivision is **RS-22** (single-family residential, minimum building site area of 22,000 square feet).

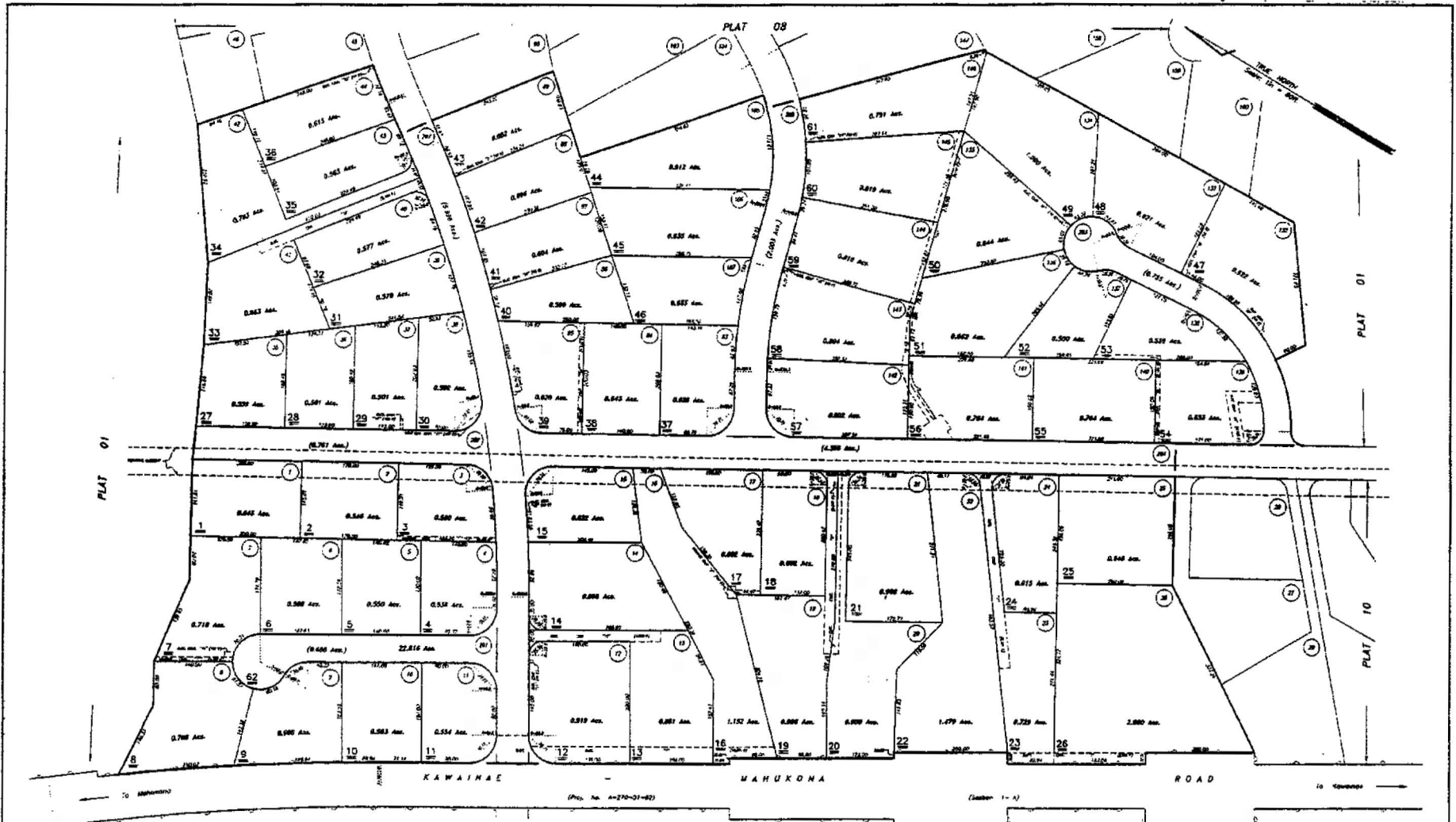

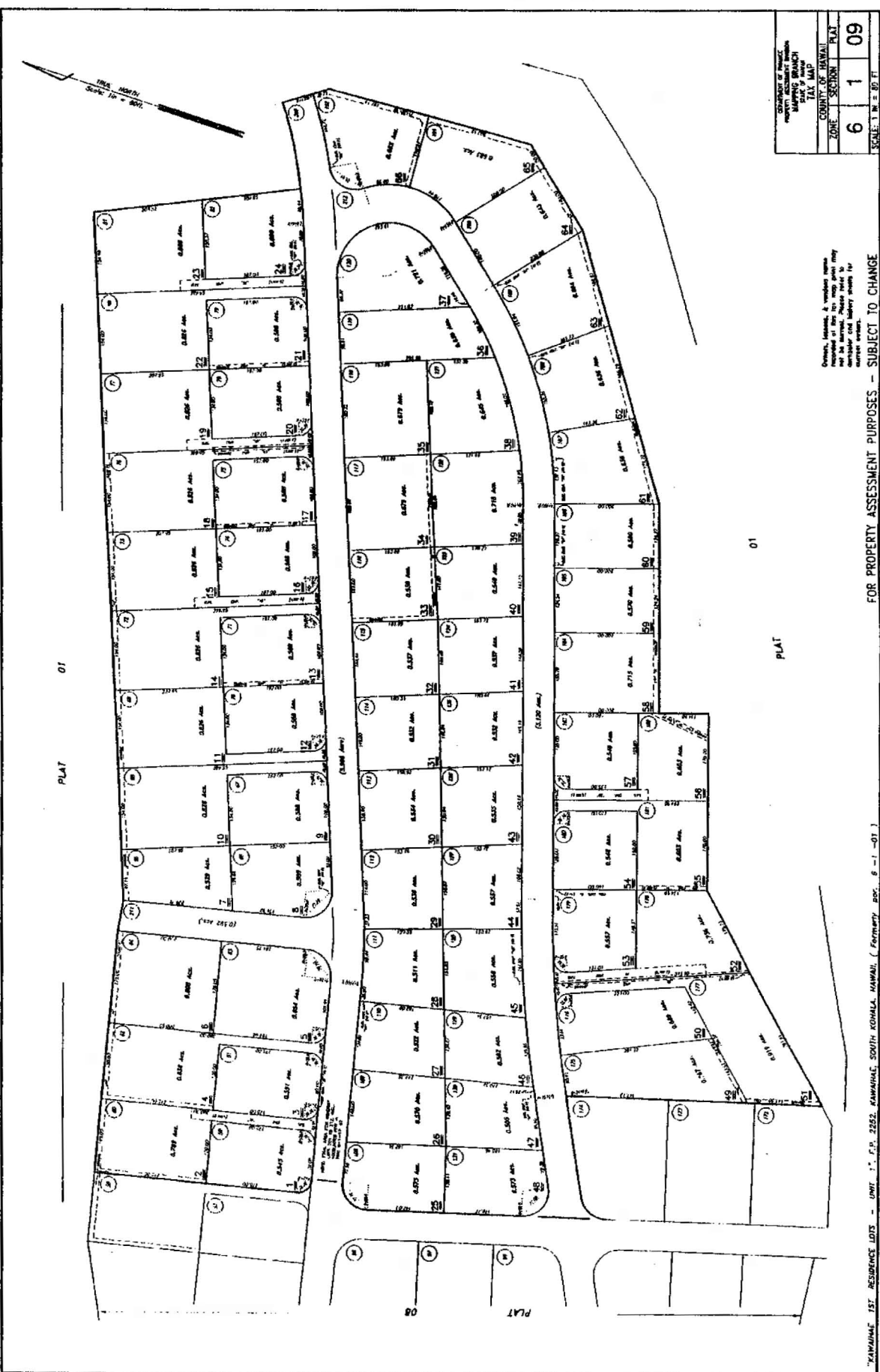

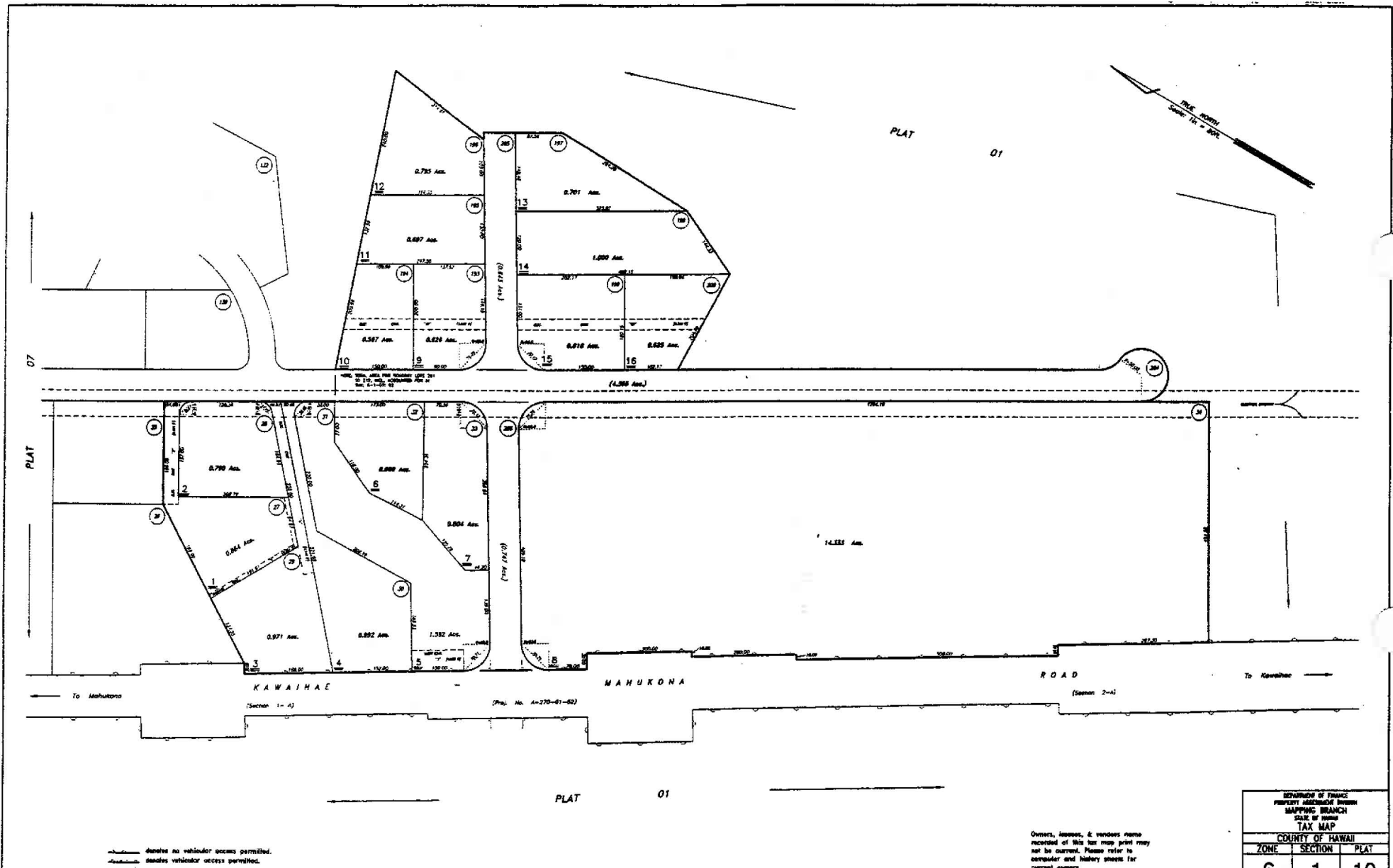
