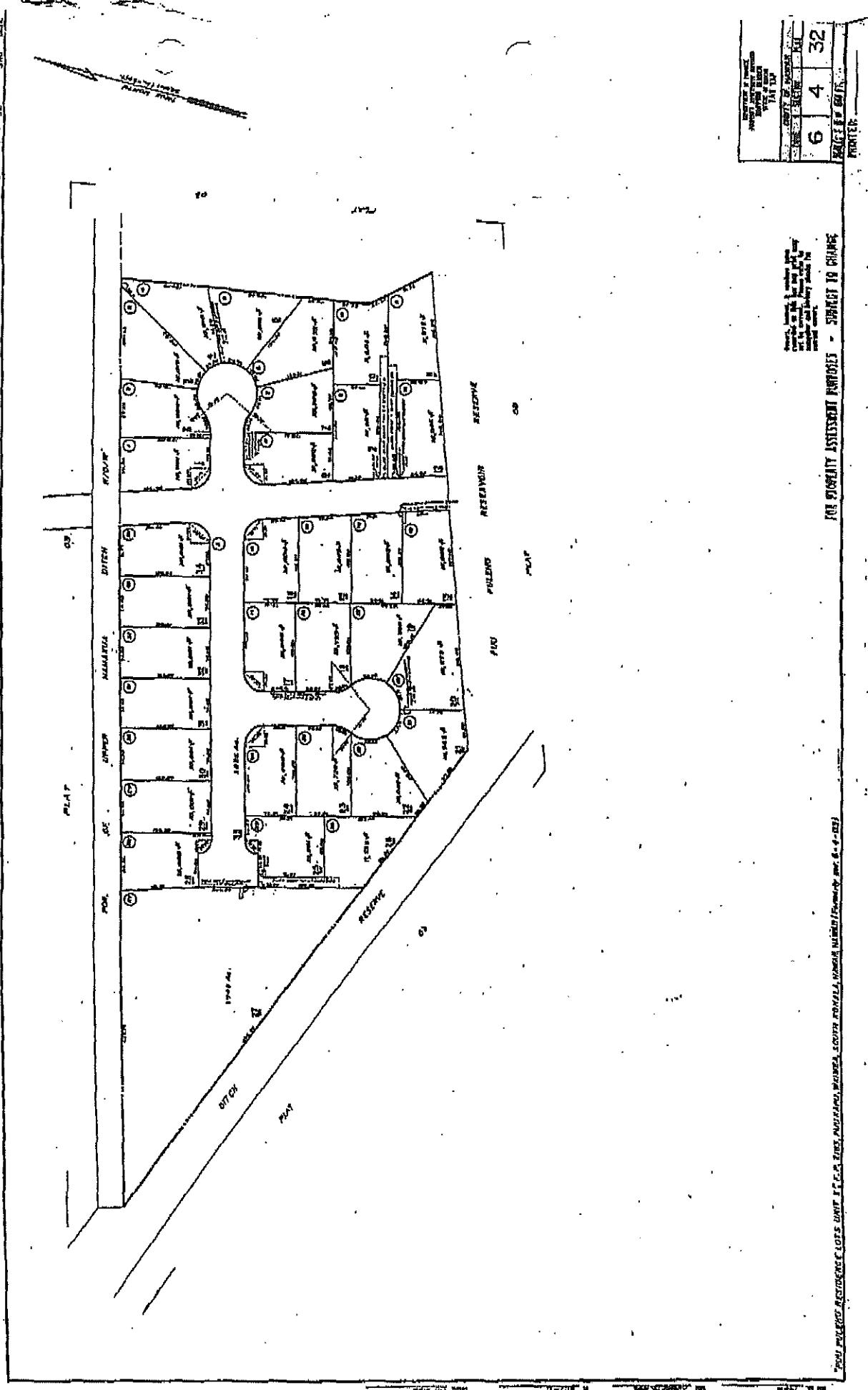
Included within this RS-10 designation are parcels within Third Division Tax Map Plat 6-4-32. A copy of this plat map is enclosed.
