AN ORDINANCE TO AMEND PORTION OF THE GENERAL PLAN OF HILO BY CHANGING THE LAND USE DESIGNATION FOR A CERTAIN AREA OF LAND FROM RESIDENTIAL—AGRICULTURAL USE TO SINGLE FAMILY RESIDENTIAL USE AT WAIAKEA HOMESTEADS.

BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF HAWAII:

SECTION 1. A portion of the General Plan of Hilo as formulated in the "Plan for the Metropolitan Area of Hilo" is hereby amended by changing the land use designation of a certain area of land situated at Waiakea Homesteads, South Hilo, Hawaii, from residential-agricultural use to single-family residential use. The boundaries and area of the said single family residential use are outlined in red on the map attached hereto, marked "Exhibit A," and by reference made a part hereof.

SECTION 2. Ordinance No. 122 is hereby repealed.

SECTION 3. This Ordinance shall take effect upon its approval.




