ORDINANCE NO. 822

AN ORDINANCE AMENDING THE COUNTY OF HAWAII GENERAL PLAN ORDINANCE NO. 439, BY DELETING FROM THE GENERAL PLAN LAND USE PATTERN ALLOCATION MAP, THE "INDUSTRIAL" DESIGNATION AND INSERTING A "HIGH DENSITY URBAN DEVELOPMENT" DESIGNATION AT THE NORTHEASTERN CORNER OF PUAINAKO STREET AND KANOELEHUA AVENUE, SOUTH HILO, HAWAII.

BE IT ORDAINED BY THE COUNTY COUNCIL OF THE COUNTY OF HAWAII, STATE OF HAWAII:

SECTION 1. The amended County of Hawaii General Plan, Ordinance No. 439, is hereby amended by deleting from the General Plan Land Use Pattern Allocation Map a portion of "Industrial" designation, not exceeding forty (40) acres, and inserting a "High Density Urban Development" designation at the northeastern corner of Puainako Street and Kanoelehua Avenue, South Hilo, Hawaii.

SECTION 2. Severability. If any provision of this ordinance or the application thereof to any person or circumstances is held invalid, such invalidity shall not affect other provisions or applications of the ordinance, and to this end the provisions of this ordinance are declared to be severable.

SECTION 3. This ordinance shall take effect upon its approval.

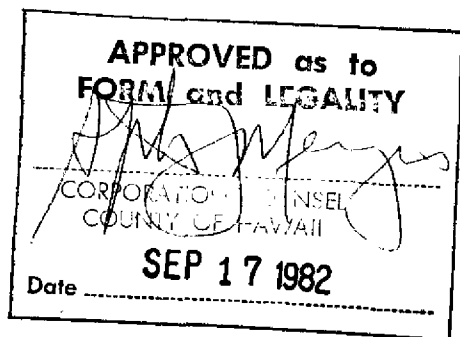

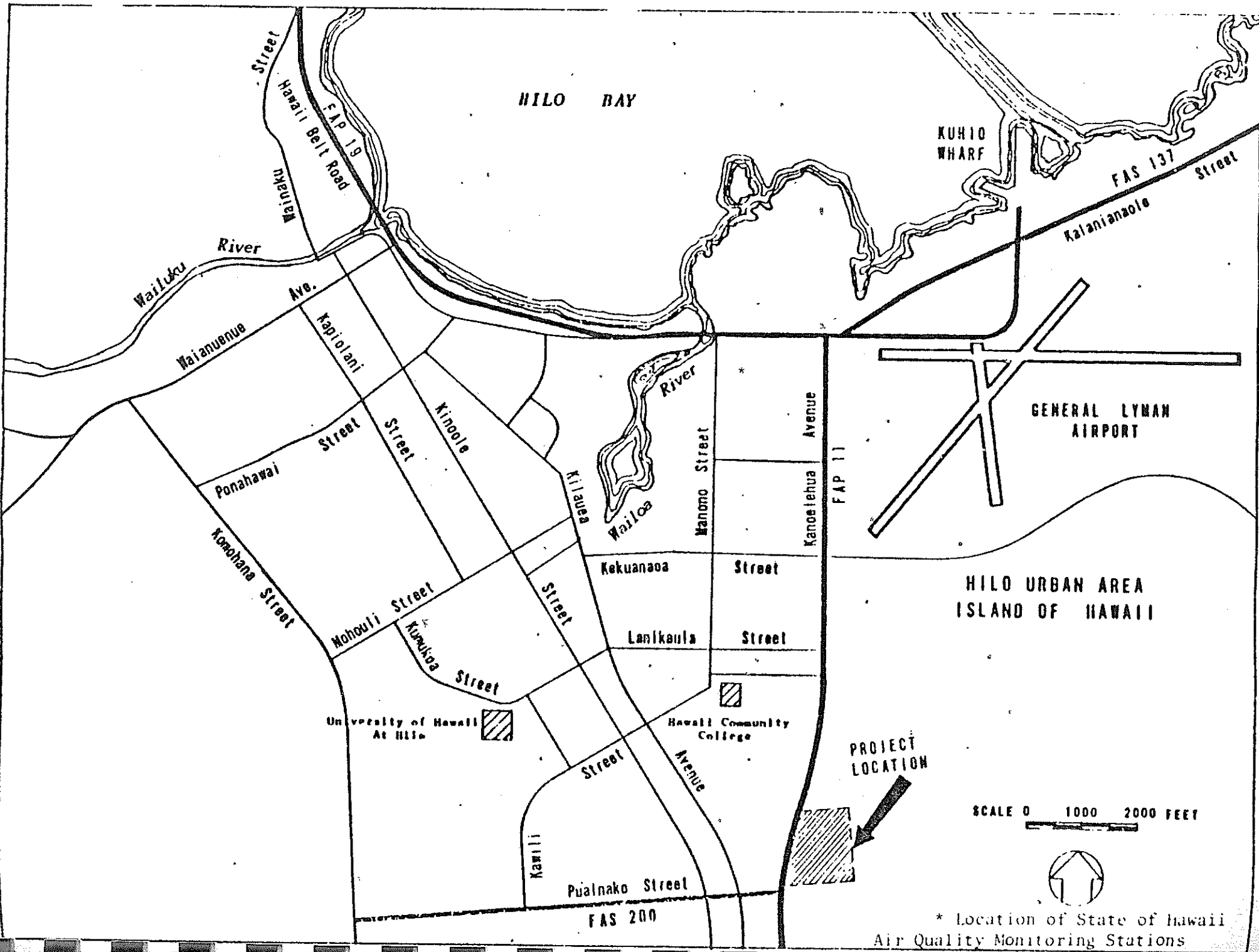

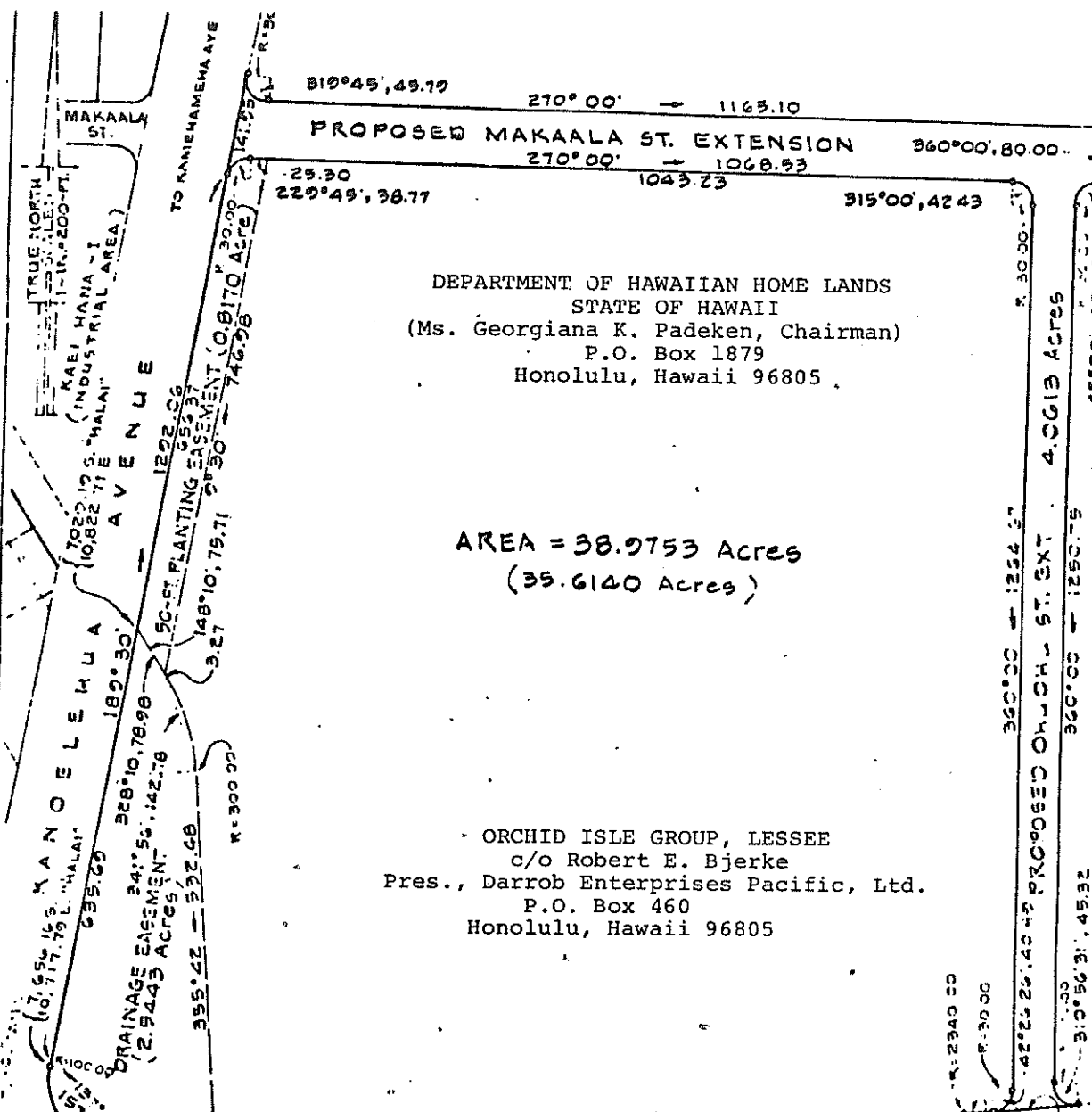

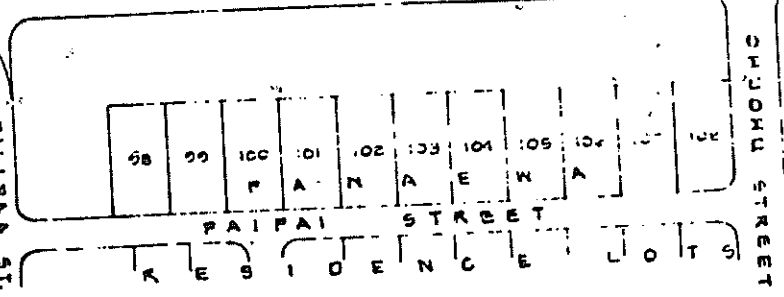
