ORDINANCE NO. 15 82

AN ORDINANCE AMENDING THE COUNTY OF HAWAI'I GENERAL PLAN AS ADOPTED BY ORDINANCE NO. 05 25 AND AMENDED BY ORDINANCE NOS. 06 153, 12 89 AND 14 87, AND BY AMENDING MAP 14 OF THE LAND USE PATTERN ALLOCATION GUIDE MAP BY CHANGING THE LAND USE DESIGNATION FROM LOW DENSITY URBAN AND IMPORTANT AGRICULTURAL LAND TO MEDIUM DENSITY URBAN FOR KEA'AU VILLAGE AND THE IMMEDIATELY SURROUNDING AREAS, KEA'AU VILLAGE, KEA'AU, PUNA, ISLAND OF HAWAI'I.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAI'I:

SECTION I. <u>Purpose</u>. The purpose of this ordinance is to amend Map 14 of the County of Hawai'i General Plan Land Use Pattern Allocation Guide (LUPAG) Map in accordance with Section 3-15, Hawai'i County Charter, and Section 16.2 Interim Amendments, Hawai'i County General Plan adopted by Ordinance No. 05 25 and amended by Ordinance Nos. 06 153, 12 89 and 14 87.

SECTION 2. The County of Hawai'i General Plan Land Use Pattern Allocation Guide (LUPAG) Map is hereby amended to designate the area in the vicinity of Kea'au Village and immediately surrounding areas, Kea'au, Puna, Island of Hawai'i, from "Low Density Urban" and "Important Agricultural Land" to "Medium Density Urban" all as shown on the map attached hereto, marked Exhibit "A" and by reference made a part hereof.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect other provisions of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.


