J. M. Swanzy



all that piece of land situate at Moanalulu in the District of North Kilo Island of Hawaii and described as follows:

## Section No. 4

Beginning at an ohia tree marked x at the foot which is set a wrought iron tube 12" in diameter, from which point the Hawaiian Govt Survey  $\Delta$  1st Sta. "Tapaaloo" bears N. 00° 25' 41" E. true dist. 6077 ft. the boundary runs by true bearings:-


1. S. 63° 02' E. 880 ft. along lower edge of forest to deep pool below falls in Tahale stream.
2. S. 34° 50' W. 2165 ft. along middle Tahale stream to a mark on rock in same at South angle.
3. N. 62° 22' W. 2181 ft. along Government forest remainder marked in middle of Ahoo stream at West angle.
4. N. 45° 55' E. 2264 ft. along middle Ahoo stream to North angle.
5. S. 61° 29' E. 860 ft. along lower edge of forest to the pit of beginning containing an area of 96.7 acres.


