We have received your letter of July 7, 2016, regarding the above subject property.

We have reviewed our department records and those of the Department of Finance–Real Property Tax Division (RPT). Our review of the records has found the following:

- Kapoho Beach Lots Subdivision was created by approval of SUB 575 on July 21, 1952. Lot 130 (TMK 1-4-010:061) of the subdivision is the access road to the subdivision from the Kalapana-Kapoho Beach Road. This roadway bisects the subject parcel into two (2) separate pieces.
- 2. Other subdivisions have affected the subject parcel; however, those only took area away from the two (2) sections of the parcel, not further subdividing the bulk portions.

Therefore, we confirm that Parcel 003 consists of two (2) separate lots of record.
