We have received your letter dated February 4, 2014, requesting verification that the subject Tax Map Key (TMK) is a pre-existing lot of record.

We have reviewed the documents submitted, our department records and those of the Department of Finance–Real Property Tax Division (RPT) in accordance with Article 11 (Pre-existing Lots) of the Subdivision Code (Sections 23-117 through 23-120). Our review of the records has found the following:

- The subject parcel, being a Portion of Lot 80, and also a Portion of Grant 5085, appears on Government Survey Registered Map No. 2137 dated June 30, 1927 and subsequently on Hawai'i Territorial Survey Plat 858 dated February, 1915.
- 2. We do not have any record of this lot being consolidated with any other lot adjacent to it.
