Determination of Lots of Record "Canney Road Homesteads" Subdivision Ola'a Reservation Lots, Puna, Hawai'i TMK: 1-8-003:007

We have received your letter of August 21, 2007, requesting verification that the subject tax map key (TMK) consists of two (2) pre-existing lots of record.

We have reviewed the documents submitted, our department records and those of the Department of Finance – Real Property Tax Division (RPT) in accordance with Article 11 (Pre-existing Lots) of the Subdivision Code (Sections 23-117 through 23-120). Our review of the records has found the following:

- 1. The subject Lots 50 and 66 were platted as a portion of the subdivision of a portion of Grant 4130 Lot 140, recorded with the Bureau of Conveyances on April 25, 1925, and entered on Pages 185 and 186 of Liber 772.
- Parcel 007 was placed on the two lots on the Taxation Maps Bureau map in the early 1950's. Lots 50 & 66 contained original land areas of 1.0 and 1.0 respectively, for a total of 2.0 acres. Subsequent actions involving the Volcano Road and the buffer Parcel 016 have adjusted those areas to 1.0387 and 1.0955 acres, respectively.
- We do not have any record of these two lots being consolidated with each other or any other lot adjoining them.
