Determination of Lots of Record Ola'a New Tract Lots, Puna, Hawai'i <u>TMK: 1-8-011:037</u>

We have received your letter of October 22, 2007, requesting verification that the subject tax map key (TMK) consists of three (3) pre-existing lots of record.

We have reviewed the documents submitted, our department records and those of the Department of Finance – Real Property Tax Division (RPT) in accordance with Article 11 (Pre-existing Lots) of the Subdivision Code (Sections 23-117 through 23-120). Our review of the records has found the following:

- The subject Lots 110, 111 and 112 were platted as a portion of the subdivision of a portion of the Ola'a New Tract Lots, Ola'a Homestead Tracts, Grant 4349, on Hawai'i Territory Survey Plat 853 dated February, 1915 which was traced from "Gov't. Survey Reg. Map No. 2250", date unknown.
- Parcel 37 was placed on the three (3) lots on the original Taxation Maps Bureau map in April 1935. Lots 110, 111 & 112 contained original land areas of 50.0 acres each, for a total of 150.0 acres.
- We do not have any record of these three (3) lots being consolidated with each other or any other lot adjoining them.
