This is in response to your communication dated October 12, 2017, requesting a determination of existing lots of record for the above-described property, Lots 75-A & 75-B of Parcel 014.

We have reviewed the documents submitted, our department records and those of the Department of Finance–Real Property Tax Division (RPT) in accordance with Article 11 (Pre-existing Lots) of the Subdivision Code (Sections 23-117 through 23-120).

Our review of the records has found the following history:

- 1. On Hawai'i Territory Survey (HTS) Registered Map No. 3050 dated 1940, are shown Lots 75 & 77, Portions of Grant 12521, containing 14,040 sq. ft. & 15,088 sq. ft., respectively;
- 2. On HTS Plat 904, dated April 1941, with a note "Lot Number 77 deleted, Lots 72 to 76 and 78 to 83 revised. By Joseph A. Aiu April 1947." shows Lot 75, all of Grant 12521, containing 18,743 sq. ft.;
- 3. On December 17, 1962, the 18,743 sq. ft. Lot 75 was consolidated (CON 17) with Parcel T, a portion of a Utility right-of-way (Grant S-14056, 912 sq. ft.), creating 19,655 sq. ft. Lot 75;

- 4. On January 4, 1963, Lot 75 was subdivided (SUB 1909) into Lots 75-A & 75-B consisting of 9,829 sq. ft. and 9,826 sq. ft., respectively; and
- 5. We do not have any record of the lots having been legally consolidated with each other or any other lands adjoining them.

Therefore, Parcel 014, presently shown as one (1) TMK Parcel with 19,655 sq. ft., is actually two (2) legal lots of record, Lot 75-A & Lot 75-B of 9,829 sq. ft. and 9,826 sq. ft., respectively.
