We have reviewed our department records and those of the Department of Finance–Real Property Tax Division (RPT) in accordance with Article 11 (Pre-existing Lots) of the Subdivision Code (Sections 23-117 through 23-120).

Our review has found that this parcel was depicted on the first Tax Maps Bureau plat map in April 1935 and contained 6.0± acres. Per the RPT field book, on June 7, 1946, the land area was revised to 5.9 acres.

Although we are uncertain of the method of creation, we affirm that the subject property is a legal lot of record since it was assigned a parcel number, has had taxes assessed for many years and has changed ownership a number of times.
