Determination of Pre-Existing Lots Portions of Kahalii, Alakahi & Mokuoniki, South Hilo, Island of Hawaii, Hawaii TMK: 2-7-09:09, 11, 12 & 22

This is to acknowledge receipt of your letter dated December 24, 1996, including documents relating to the subject properties.

Please be advised that we have reviewed your documents along with our department files as well as the Real Property Tax Division records and conclude that the subject properties consist of twenty-six (26) separate legal lots of record. That is:

- One (1) separate remainder lot of Grant 2003, Apana 2 divided by the Mamalahoa Highway;
- (2) Two (2) separate remainder lots of Grant 1349:2 divided by the Railway;
- (3) Two (2) separate remainder Lots of Grant 807 divided by the Railway;
- (4) Two (2) separate remainder lots of Grant 1962 divided by the Scenic Drive;
- (5) One (1) separate lot identified as School Grant 2, Lot 4;
- (6) One (1) separate remainder lot of Grant 1037 divided by the Mamalahoa Highway;
- (7) One (1) separate lot (Parcel 11) a portion of Grant 2945:1;

- (8) One (1) separate lot (Parcel 9) a portion of Grant 1888 divided by the Scenic Drive;
- (9) Two (2) separate remainder lots of Grant 957 divided by the Railway;

- (11) Two (2) separate remainder lots of Grant 1340 divided by the Railway;
- (12) One (1) separate remainder lot portion of Grant 2383; and
- (13) Eight (8) separate remainder lots contained within the Consolidated Railway.

It is our understanding that you intend to consolidate and resubdivide these pre-existing lots of record.
