Lot of Record Determination Kukuihaele, Hamakua, Island of Hawaii, Hawaii TMK: (3) 4-8-008:011

We have received your letter of December 9, 2004, regarding this property and we have reviewed the documents submitted and our department records and have found the following:

- According to records in our Real Property Tax Office, Parcel 11, formerly 4.711 acres in area was "dropped" in 1966 and its land area was added to Parcel 1.
- 2. Former Parcel 11 was a portion of Grant 929, Apana 1. Parcel 11 existed on the first Tax Maps drawn in the 1930's and our Real Property Tax Office records show assessments in 1941.
- Parcel 1 is a portion of Grant 930.
- 4. The Planning Department does not have record of Parcel 11 being legally consolidated with the portion of Grant 930 (Parcel 1).

Based on the above, we agree with you that TMK: (3) 4-8-008:001 with a total area of 13.262 acres is comprised of two separate lots, a portion of Grant 930 and a portion of Grant 929, Apana 1. You may want to have a modern metes and bounds survey be conducted for a more accurate and current land area determination and that a map reflecting this information may be submitted for certification.
