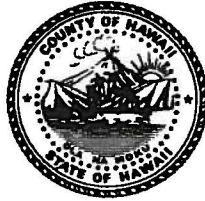

**Pre-existing Lots of Record Determination
Lots 4 & 5, Being Grant 8014, Sundry Lots, Kamā'oa Homesteads,
Kamā'oa-Pu'u'eo Government Tract, Ka'ū, Island of Hawai'i, Hawai'i
TMK: 9-3-003:064**

We have received your correspondence of November 9, 2017.

We have reviewed our department records, and those of the Department of Finance-Real Property Tax Division (RPT) in accordance with Article 11 (Pre-existing Lots) of the Subdivision Code (Sections 23-117 through 23-120).

Our review of the records has found the following:

1. Lots 4 & 5 are shown on Registered Map 1807 dated 1894;
2. Parcel 004 is shown on the first Tax Map Bureau Plat of October, 1935, identified as Grant 7831, and Grant 8014, consisting of Lots 4, 5, 6, 7, 9, 10, 11, 12, & 15, having land areas of 8.0 acres each and Lot 16 with 6.0 acres;
3. On a subsequent TMK Plat of around 1956, Lots 4 & 5 were separated from Parcel 004 and issued Parcel 064; and
4. We have no record of the lots having been consolidated with each other or any adjacent lands.

Given the above, we have determined that Parcel 064 consists of two (2) pre-existing lots of record.

The owners may want to further research the lots to ascertain legal access to them.
