DETERMINATION OF PRE-EXISTING LOTS OF RECORD Being Lots 12 & 13 of Wood Valley Homesteads, Being Also Grant 7370 Wood Valley, Waimuku, Kaʻū, Island of Hawaiʻi, Hawaiʻi Tax Map Key: (3) 9-6-008:012

This responds to your correspondence of March 12, 2021, requesting a determination of pre-existing lots of record for TMK (3) 9-6-008:012.

We have reviewed our department records and those of the Department of Finance–Real Property Tax Division (RPT) in accordance with Article 11 (Pre-existing Lots) of the Subdivision Code (Sections 23-117 through 23-120).

Our review of the records has found the following:

- 1. Subdivision of Wood Valley Homesteads into Lots 1 through 34, inclusive (reference map dated July 1911 by B.F. Howland, Surveyor);
- TMK 9-6-008:012 depicted on the first Tax Map Plat of January 1936 as one Parcel containing two portions, Lot 12 with 12.50 acres and Lot 13 with 13.30 acres;
- 3. Both lots were created prior to November 22, 1941 and, therefore, TMK 9-6-008:012 contains two (2) lots of record; and
- We find no record of these lots having been consolidated with each other or any other adjacent land.

Therefore, we confirm that TMK 9-6-008:012, containing 25.80 acres, consists of two (2) pre-existing lots of record, being Lot 12 and Lot 13.
