During the early 1960's, some files make reference to "temporary" district boundary amendments. Ordinance or Docket numbers were not used. Official letters from the State Land Use Commission included a Reference number on the letter. Some files made reference to Petition numbers. One GIS record in particular (64_000) did not have any reference number available, just a letter.

The Map Tip feature will not be available due to the complexity of the data layer. Users may choose to use the Identify feature.
