- (c) All construction drawings together with approved site plan drawn to scale submitted with the ohana dwelling building permit application shall denote location and identify required two (2) off-street parking spaces.
- (d) The ohana dwelling shall conform to all requirements of codes and statutes pertaining to access and building construction. Please refer to your copy of the Department of Public Works memorandum dated November 7, 1991.
- (e) The applicant shall conform to State Department of Health standards and regulations and following comment(s) dated October 30, 1991:

"The subject lot is located in the Critical Wastewater Area (CWA) where new cesspools would not be allowed and the existing cesspool would not be allowed to accept additional sewage. If the owner wishes to construct a new treatment individual wastewater system such as septic tank system for both dwelling units, we have no objections.
