ORDER ALLOWING APPLICATION FOR VARIANCE

The application of C. L. Chow for a variance from the zoning regulations having come before the Planning and Traffic Commission at a public hearing after due publication of notice thereof, on Monday, January 8, 1951, the Commission finds that:

1. The land for which the variance is requested is located on a portion of Lot 5, West Tract, L. C. Aw. 5122, in the land of Ponahawai, South Hilo, Hawaii, and indicated on the Taxation Maps as a portion of parcel 2-2-08-14;

2. Pertinent zoning regulations applicable to said land are Section 3-C and Section 11, Ordinance No. 45 of the Revised Ordinances of the County of Hawaii 1947, which specifically prohibit the use of any land for any purpose other than is permitted in the district;

3. The land for which the variance is requested is owned by the applicant;

7. The desired relief may be granted and at the same time the public interest and general welfare will be protected, and the fire, health, and safety hazards of the surrounding property will not be affected.

NOW, THEREFORE, the Planning and Traffic Commission, pursuant to the authority vested in it by Section 21 of Ordinance No. 45 of the Revised Ordinances of the County of Hawaii 1947, hereby grants to the applicant, above-named, a variance from the terms of Section 3-C and Section 11, Ordinance No. 45 of the Revised Ordinances of the County of Hawaii 1947, and hereby authorizes a variance in use to operate a fish and meat smoking business in a Business District; subject, however, to the following conditions:

- 1. That the applicant employ not more than 3 persons.
- 2. That all equipment be limited in use to the hours of 6:00 a.m. to 6:00 p.m.
- 3. That the applicant keep the premises in a sanitary condition.
- 4. That the variance be allowed for a term of 2 years or its prior abandonment.
