AN ORDINANCE AMENDING SECTION 7.06, THE NORTH AND SOUTH KOHALA DISTRICTS ZONE MAP, ORDINANCE NO. 63 (ZONING ORDINANCE), REVISED ORDINANCES OF THE COUNTY OF HAWAII 1967, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION OF CERTAIN LANDS FROM AGRICULTURE TO MULTIPLE FAMILY RESIDENTIAL AND OPEN IN KAWAIHAE 2ND. SOUTH KOHALA, HAWAII.

BE IT ORDAINED BY THE BOARD OF SUPERVISORS IN AND FOR THE COUNTY OF HAWAII:

SECTION 1. Section 7.06 of Ordinance No. 63 (Zoning Ordinance), Revised Ordinances of the County of Hawaii 1967, as amended, is hereby further amended by adding thereto the following subsections:

"7.06(a) The District Classification of the following area situated at Kawaihae 2nd, South Kohala, Hawaii, shall be Multiple Family Residential:
