## COUNTY OF HAWAII - STATE OF HAWAII ORDINANCE NO. 141\_\_\_

AN ORDINANCE AMENDING SECTION 7.02, THE NORTH KONA ZONE MAP, AND SECTION 7.05, THE KAILUA-HONALO URBAN ZONE MAP, ORDINANCE NO. 63 (ZONING ORDINANCE), REVISED ORDINANCES OF THE COUNTY OF HAWAII 1967, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM AGRICULTURE (A-5a) TO AGRICULTURE (A-1a) IN HOKUKANO 1ST, NORTH KONA, HAWAII, AND FROM SINGLE-FAMILY RESIDENTIAL TO RESORT-HOTEL IN KEAUHOU 2ND, NORTH KONA, HAWAII.

BE IT ORDAINED BY THE BOARD OF SUPERVISORS IN AND FOR THE COUNTY OF HAWAII:

SECTION 1. Section 7.02 of Ordinance No. 63 (Zoning Ordinance), Revised Ordinances of the County of Hawaii 1967, as amended, is hereby further amended by adding thereto the following subsection.

"7.02 d) The District Classification of the following area situated at Hokukano lst, North Kona, Hawaii, shall be Agriculture Zone (A-la):

Beginning at the northeast corner of this parcel of land on the west side of the Mamalahoa Highway, the coordinates of said point of beginning referred to Government Survey Triangulation Station "Puu Chau" being 4,823.39 feet north and 10,432.46 feet east, and thence running by azimuths measured clockwise from true south:

 5. 253<sup>0</sup> 39' 30" 260.05 feet along the middle of a stonewall on the south side of a 30.00 feet wide roadway to the point of beginning and containing an area of 1.00 acre more or less.

All as outlined in red on the map attached hereto marked "Exhibit A" and by reference made a part hereof."

SECTION 2. Section 7.05 of aforesaid ordinance, as amended, is hereby further amended by adding thereto the following subsection.

"7.05 b) The District Classification of the following area situated at Keauhou 2nd, North Kona, Hawaii, shall be Resort-Hotel Zone (VH-.75):

Beginning at the Southeast corner of this parcel of land, the South corner of Lot A of the Keauhou Beach Section, the coordinates of said point of beginning referred to Government Survey Triangulation Station "Keauhou Coast" being 2045.38 feet North and 486.13 feet East, and running thence by azimuths measured clockwise from true South:

- 1. 690 33' 30" 398.00 feet along the remainder of R. P. 7844, L. C. Aw. 7715, Ap. 12 to L. Kamehameha; Thence along the coastline for the next two courses, the direct azimuths and distances being
- 2. 199<sup>0</sup> 32' 434.97 feet;
- 3. 274° 28' 20" 166.45 feet;
- 4. 346 34 30 265.21 feet along Lot A of the Keauhou Beach Section to the point of beginning and containing an area of 1.87 acres, more or less.

All as outlined in red on the map attached hereto marked "Exhibit A" and by reference made a part hereof."






This Bill further amends Ordinance No. 36, Section 2(i), by adding that all school busses shall be equipped with dual or supplementary braking system.
