AN ORDINANCE AMENDING SECTION 7.24 (KAU ZONE MAP) CF ORDINANCE NO. 63 (ZONING ORDINANCE), REVISED ORDINANCES OF THE COUNTY OF HAWAII 1967, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FOR AN AREA OF LAND FROM AGRICULTURAL (A-20a) TO AGRICULTURAL (A-5a) IN KIOLAKAA-KEAA HOMESTEADS, KAU, HAWAII.

BE IT ORDAINED BY THE BOARD OF SUPERVISORS IN AND FOR THE COUNTY OF HAWAII:

SECTION 1. Section 7.24 of Ordinance No. 63 (Zoning Ordinance), Revised Ordinances of the County of Hawaii 1967, as amended, is hereby amended by adding thereto the following subsection:

"7.24(a). The district classification of the following area situated at Kiolakaa-Keaa Homesteads, Kau, Hawaii, shall be Agricultural (A-5a):

Beginning at a pipe at the southwest corner of this parcel of land, the coordinates of said point of beginning referred to Government Survey Triangulation Station "Stein 2" being 886.69 feet north and 19,180.84 feet west and running by azimuths measured clockwise from true south:

- 1. 245° 06' 15" 348.23 feet along the remainder of Grant 9560 to David M. Keliikoa to a pipe in the middle of a stonewall;
- 2. 334⁰ 35' 10" 1030.39 feet along the middle of a stonewall along a portion of Grant 7225 to Job Nalau Kamoku to a pipe on the north side of the Mamalahoa Highway;

Thence along the north side of the Mamalahoa Highway for next ten (10) courses, the azimuths and distances being:


