## COUNTY OF HAWAII - STATE OF HAWAII ORDINANCE NO. 281

AN ORDINANCE AMENDING SECTION 7.05, THE KAILUA-HONALO URBAN ZONE MAP, ORDINANCE NO. 63 (ZONING ORDINANCE), REVISED ORDINANCES OF THE COUNTY OF HAWAII 1967, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM SINGLE FAMILY RESIDENTIAL (RS-10) TO VILLAGE COMMERCIAL (CV-7.5) IN HONUAINO 3RD, NORTH KONA, HAWAII, COVERED BY TAX MAP KEY 7-9-07:30.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.05 of Ordinance No. 63 (Zoning Ordinance), Revised Ordinances of the County of Hawaii 1967, as amended, is hereby further amended by adding thereto the following subsection:

"7.05(h). The district classification of the following area situated at Honuaino 3rd, North Kona, Hawaii, shall be Village Commercial (CV-7.5):

Beginning at a point at the northeast corner of this parcel of land, the coordinates of which referred to Government Survey Triangulation Station "Puu Ohau" being 6,721.42 feet north and 9,596.48 feet east and thence running by azimuths measured clockwise from true south:

Along the westerly side of Mamalahoa Highway on a 5699.65 foot radius curve to the right, the chord azimuth and distance being:




