BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.06 of Ordinance No. 63 (Zoning Ordinance), Revised Ordinances of the County of Hawaii 1967, as amended, is hereby further amended by adding thereto the following subsections:

"7.06(c). The district classification of the following area situated at Pueke, North Kohala, Hawaii, shall be Single Family Residential (RS-15):

Commencing at the southeast corner of this parcel of land, which is also the southwest corner of Lot 21 and the northerly boundary of the Mahukona-Niulii Government Road, the coordinates referred to Government Survey Triangulation Station "Kauhola" being 6956.61 feet South and 2883.64 feet West and running by true azimuths measured clockwise from true South:


- 1. 102⁰ 47' 30" 150.00 feet along the southerly boundary of the proposed lot and the northerly boundary of the Mahukona-Niulii Government Road;
- 2. 192° 47' 30" 363.00 feet along the westerly boundary of the proposed lot;
- 3. 282⁰ 47' 30" 150.00 feet along the northerly boundary of the proposed lot to a point on the westerly boundary of Lot 21;
- 4. 12° 47' 30" 363.00 feet along the easterly boundary of the proposed lot and westerly boundary of Lot 21 to the point of beginning and containing an area of 1.25 acres.

All as outlined in red on the map attached hereto, marked Exhibit "A," and by reference made a part hereof."

SECTION 2. This ordinance shall take effect upon its approval.


