AN ORDINANCE AMENDING SECTION 7.03, THE SOUTH KONA ZONE MAP, ORDINANCE NC. 63 (ZONING ORDINANCE), REVISED ORDINANCES OF THE COUNTY OF HAWAII 1967, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM AGRICULTURAL (A-5a) TO AGRICULTURAL (A-1a) IN KEEI 2ND, SOUTH KONA, HAWAII, COVERED BY TAX MAP KEY 8-3-10:50.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.03 of Ordinance No. 63 (Zoning Ordinance), Revised Ordinances of the County of Hawaii 1967, as amended is hereby further amended by adding thereto the following subsection:

"7.03(b). The district classification of the following area situated at Keei 2nd, South Kona, Hawaii, shall be Agricultural (A-la):

Beginning at a pipe at the Northeast corner of this lot, being also the Southwest corner of Lot 2, and on the West side of Keei Middle Road to Napoopoo, the coordinates of point of beginning referred to Government Triangulation Station "LAE O KANONI" being 5445.5 feet North and 12,260.1 feet East, thence running by true azimuths measured clockwise from true South:

- 1. 344° 04' 216.96 feet along the West side of Keei Middle Road to Napoopoo, to a pipe;
- 2. 84⁹ 15' 386.80 feet along the North side of 30-foot Road Reserve, to a pipe;
- 3. 164° 04' 240.66 feet along the remainder of L. C. Aw. 5524, Apana 5, R. P. 1663 to L. Konia, to a pipe;
- 4. 267° 40' 391.67 feet along Lot 2, to the point of beginning; and containing an area of 2.0 acres.

All as outlined in red on the map attached hereto, marked Exhibit "A," and by reference made a part hereof."




