AN ORDINANCE AMENDING SECTION 7.03, THE SOUTH KONA ZONE MAP, ORDINANCE NO. 63 (ZONING ORDINANCE), REVISED ORDINANCES OF THE COUNTY OF HAWAII 1967, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM SINGLE FAMILY RESIDENTIAL (RS-10) TO VILLAGE COMMERCIAL (CV-10) IN KEOPUKA, SOUTH KONA, HAWAII, COVERED BY TAX MAP KEY 8-1-15: POR. OF 27.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.03 of Ordinance No. 63 (Zoning Ordinance), Revised Ordinances of the County of Hawaii 1967, as amended, is hereby further amended by adding thereto the following subsection:

"7.03(e). The district classification of the following area situated at Keopuka, South Kona, Hawaii, shall be Village Commercial (CV-10):

Beginning at a pipe in concrete on the southerly boundary of this lot, and on the northerly side od Keopuka Road, the coordinates of which referred to Government Survey Triangulation Station "PUU OHAU" being 4513.29 feet South and 11,236.06 feet East, and thence running by azimuths measured clockwise from true South:

Along the northeasterly side of Lot 1-E (16 feet wide Roadway) on a 10.00 feet radius curve to the right, the direct chord azimuth and distance being:

1.	115°	31'	30"	14.14	feet	to a pipe in concrete;
2.	160 <sup>0</sup>	31'	30"	186.67	feet	along the northeasterly side of Lot 1-E (16 feet wide Roadway) to a pipe in concrete;
3.	250 <sup>O</sup>	31'	30"	73.60	feet	along Lot 4J, along remainder of Grant 1584 to Daniel Barrett, to a pipe in concrete;
4.	333 <sup>0</sup>	27'		198.17	feet	along Lot 1-A-2, along remainder of Grant 1584 to Daniel Barrett;
5.	70 <sup>0</sup>	31'	30"	88.02	feet	along the northerly side of Keopuka Road, to the point of beginning and containing an area of 16,854 square feet.

All as outline in red on the map attached hereto, marked Exhibit "A," and by reference made a part hereof."

SECTION 2. This Ordinance shall take effect upon its approval.






