BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.31 of Ordinance No. 63 (Zoning Ordinance), Revised Ordinances of the County of Hawaii 1967, as amended, is hereby further amended by adding thereto the following subsection:

"7.31(a). The district classification of the following area situated at Pepeekeo and Makahanaloa, South Hilo, Hawaii, shall be General Industrial (MG-5a):

Beginning at a point at the southwest corner of this parcel of land, the coordinates of said point of beginning referred to Government Survey Triangulation Station "Alala" being 2672.00 feet north and 7738.00 feet east, and running by azimuths measured clockwise from true south:

- 1. 188° 24' 50" 328.00 feet along the remainder of R. P. 7192, L. C. Aw. 8559-B, Apanas 17 and 18 to Wm. C. Lunalilo; thence along the remainder of R. P. 7192, L. C. Aw. 8559-B, Apanas 17 and 18 to Wm. C. Lunalilo for the next five (5) courses:
- 2. 240⁰ 04! 40" 424.00 feet;
- 3. 45° 24' 120.40 feet;
- 4. 317⁰ 51' 10" 146.40 feet;
- 5. 38° 35: 50" 427.85 feet;
- 6. 86° 58' 40" 161.30 feet to the point of beginning and containing an area of 2.640 acres.

All as outlined in red on the map attached hereto, marked Exhibit "A" and by reference made a part hereof."



AMENDMENT TO THE COUNTY ZONING ORDINANCE


