## ORDINANCE NO. 482

AN ORDINANCE AMENDING SECTION 7.29, THE CITY OF HILO ZONE MAP, ORDINANCE NO. 63 (ZONING ORDINANCE), REVISED ORDINANCES OF THE COUNTY OF HAWAII 1967, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM AGRICULTURAL (A-1a) TO SINGLE FAMILY RESIDENTIAL (RS-15) IN WAIAKEA HOMESTEADS, WAIAKEA, SOUTH HILO, HAWAII, COVERED BY TAX MAP KEY 2-4-03:37.

### BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.29 of Ordinance No. 63 (Zoning Ordinance), Revised Ordinances of the County of Hawaii 1967, as amended, is hereby further amended by adding thereto the following subsection:

"7.29 (h). The district classification of the following area situated at Waiakea Homesteads, Waiakea, South Hilo, Hawaii, shall be Single Family Residential (RS-15):

Beginning at the northwest corner of Parcel 4, the coordinates of said point referred to Government Survey Triangulation Station "HALAI" being 12,492.13 feet South and 1,747.27 feet West, thence running by azimuths measured clockwise from true South:

1.	265 <sup>0</sup>	40 ·	242.00	feet along Kawailani Street;
2.	355°	40 •	1800.00	feet along Grant 12194;
<b>3</b> •	85°	40'	242.00	feet along Grant 11637;
4.	175 <sup>0</sup>	40*		feet along Parcel 3 to the point of beginning and containing an area of 435,600 square feet, or 10.00 Acres, more or less.

All as outlined in red on the map attached hereto, marked Exhibit "A" and by reference made a part hereof."

SECTION 2. Section 1 of this ordinance shall take effect forthwith upon the conditions that (A) the area be zoned in two (2) increments. The first increment shall consist of fourteen (14) lots and the second increment shall consist of the remaining lots. The effective date of zoning for the

second increment shall be after development has occurred on the first zoning increment. Development is defined as building permits issued for residential dwelling units and construction partially completed--partially completed in the sense of having roofs on those units--on a minimum of six (6) or forty-three (43) percent of the lots of the first increment. This would insure that a minimum of twenty-five (25) percent housing construction would occur on the total area requested; and (B) the owner or lessee of the subject area submit a subdivision plan and secure preliminary approval no later than one year from the date of approval of the subject request. Should this condition not be met, the Planning Commission shall reserve the right to initiate action to rezone the subject area to its former designation.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.




