# COUNTY OF HAWAII - STATE OF HAWAII ORDINANCE NO. 486

AN ORDINANCE AMENDING SECTION 7.20, THE KURTISTOWN ZONE MAP, ORDINANCE NO. 63 (ZONING ORDINANCE), REVISED ORDINANCES OF THE COUNTY OF HAWAII 1967, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM SINGLE-FAMILY RESIDENTIAL (RS-20) TO NEIGHBORHOOD COMMERCIAL (CN-10) AT OLAA, PUNA, HAWAII, COVERED BY TAX MAP KEY 1-7-19:PORTION OF 12.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.20 of Ordinance No. 63 (Zoning Ordinance), Revised Ordinances of the County of Hawaii 1967, as amended, is hereby further amended by adding thereto the following subsection:

"7.20 (a). The district classification of the following area situated at Olaa, Puna, Hawaii, shall be neighborhood commercial (CN-10):

Beginning at the west corner of this parcel of land at the north corner of Lot 1 the coordinates of said point of beginning referred to Government Survey Triangulation Station "OLAA" being 2020.32 feet south and 372.87 feet west and running by azimuths measured clockwise from true south:

- 1. 191° 50' 95.48 feet along old Volcano Road;
- 2. 303° 35' 132.46 feet along remainder of Lot 2;
- 3. 27° 49' 78.48 feet along same;
- 4. 1170 49' 105.50 feet along Lot 1 to the point of beginning and containing an area of 10,013 square feet or 0.2299 acre.

All as outlined in red on the map attached hereto, marked Exhibit "A" and by reference made a part hereof."

SECTION 2. Section 1 of this ordinance shall take effect forthwith upon the conditions that (A) the owner or lessee of the subject property be responsible for securing a building permit and assuring construction started for a launderette within one year from the official date of approval of the change of zone; and (B) the owner

or lessee of the subject property submit a subdivision plan for tentative approval for the requested area within one year from the date of approval of the change of zone. Should any of these conditions not be met, the Planning Commission shall reserve the right to re-evaluate the area and initiate proceedings to rezone it to its former designation.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.






