## COUNTY OF HAWAII - STATE OF HAWAII ORDINANCE NO. 188

AN ORDINANCE AMENDING SECTION 7.09, THE KAMUELA ZONE MAP, ORDINANCE NO. 63 (ZONING ORDINANCE), REVISED ORDINANCES OF THE COUNTY OF HAWAII 1967, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM VILLAGE COMMERCIAL (CV-7.5) TO SINGLE FAMILY RESIDENTIAL (RS-10) AT WAIMEA, SOUTH KOHALA, HAWAII, COVERED BY TAX MAP KEY 6-5-03:PORTION OF 11 & 12.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.09 of Ordinance No. 63 (Zoning Ordinance), Revised Ordinances of the County of Hawaii 1967, as amended, is hereby further amended by adding thereto the following subsection:

"7.09 (a). The district classification of the following area situated at Waimea, South Kohala, Hawaii, shall be single family residential (RS-10):

Beginning at the northwest corner of this parcel of land, the coordinates of which referred to Government Survey Triangulation Station "WEST BASE" being 2,170.04 feet south and 4,394.20 feet west and running by azimuths measured clockwise from true South:

- 1. 277° 30' 451.70 feet along Grant 7276 to Eunice F. Lindsay, Grant 7250 to Kaliko Mainaaupo, Grant 6305 to Kaliko Mainaaupo and Grant 6304 to William Heeb;
- 2. 7<sup>O</sup> 30' 400.00 feet along Government Land;
- 3. 97° 30' 451.70 feet along Government Land;
- 4. 187 30' 400.00 feet along remainders of Grant 7852 to William M. S. Lindsay and Grant 6307 to Joseph K. Miller to the point of beginning and containing an area of 4.147 acres.

"All as outlined in red on the map attached hereto, marked Exhibit "A" and by reference made a part hereof."

SECTION 2. Section 1 of this ordinance shall take effect forthwith upon the condition that the owner or lessee of the subject property submit a subdivision plan and secure preliminary approval no later than one year from the date of approval of the change of zone request. Should this condition not be met, the Planning Commission shall reserve the right to initiate action to rezone the area to its former designation.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.






