BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.09 of Ordinance No. 63 (Zoning Ordinance), Revised Ordinances of the County of Hawaii 1967, as amended, is hereby further amended by adding thereto the following subsection:

"7.09 (b). The following area situated at Waimea, South Kohala, Hawaii, shall be single-family residential (RS-15):

Beginning at the east corner of this lot, being the west corner of Hokuula Road and a 20 foot road reservation, the co-ordinates of said point of beginning referred to Government Survey Triangulation Station "West Base" being 558.41 feet south and 3380.58 feet west as shown on Government Survey Registered Map No. 2470 and running by true azimuths:

- 1. 55° 09' 193.3 feet along Hokuula Road;
- 2. 97° 30' 226.8 feet along Hokuula Road;
- 3. 187° 30' 535.7 feet along Lot 16, Block 1 to an unmarked point;
- 4. 3250 09' 547.7 feet along 20 foot road reservation to the point of beginning. Area: 2.61 acres.

All as outlined in red on the map attached hereto, marked Exhibit "A" and by reference made a part hereof."

SECTION 2. Section 1 of this ordinance shall take effect forth-with upon the condition that the owner or lessee of the subject area submit a subdivision plan and secure preliminary approval no later than one year from the date of approval of the change of zone request. Should this condition not be met, the Planning Commission shall reserve the right to initiate action to rezone the area to its former designation.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.






