AN ORDINANCE AMENDING SECTION 7.07, THE HAWI-KAPAAU ZONE MAP, ORDINANCE NO. 63 (ZONING ORDINANCE), REVISED ORDINANCES OF THE COUNTY OF HAWAII 1967, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM SINGLE-FAMILY RESIDENTIAL (RS-15) TO LIMITED INDUSTRIAL (ML-20) IN KAHEI AND KAAUHUHU, NORTH KOHALA, HAWAII, COVERED BY TAX MAP KEY 5-5-11:7.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.07 of Ordinance No. 63 (Zoning Ordinance), Revised Ordinances of the County of Hawaii 1967, as amended, is hereby further amended by adding thereto the following subsection:

"7.07 (a). The district classification of the following area situated at Kahei and Kaauhuhu, North Kohala, Hawaii, shall be Limited Industrial (ML-20):

Beginning at an iron pipe at the southeast corner of this tract of land, the northeast corner of Grant 8386 to Union Church of Kohala, and on the west side of Hoea Road, the coordinates of said point of beginning referred to Government Survey Triangulation Station "Kahei" being 663.48 feet south and 1060.72 feet east, as shown on Government Survey Registered Map 2366, thence running by azimuths measured clockwise from true south:

- 1. 990 10: 320.99 feet along Grant 8386 to Union Church of Kohala;
- 2. 180° 40' 279.09 feet along Grant 9207 to Fred C. Koelling (Lot 20 of Kahei House Lots);
- 3. 129^O 30' 76.54 feet along Grant 9207 to Fred C. Koelling (Lot 20 of Kahei House Lots);
- 4. 260° 20' 383.30 feet along Lot 6 of Land Court Application 1120 and Grant 11179 to Kohala Sugar Company;
- 5. 00 40' 443.30 feet along the west side of Hoea Road to the point of beginning and containing an area of 2.89 acres.

"All as outlined in red on the map attached hereto, marked Exhibit "A" and by reference made a part hereof."

SECTION 2. Section 1 of this ordinance shall take effect forth-with upon the condition that the owner or lessee of the subject property secure a building permit and begin construction of permanent structures within one (1) year from the date of approval of the change of zone request.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.




