# COUNTY OF HAWAII - STATE OF HAWAII ORDINANCE NO. \_507

AN ORDINANCE AMENDING SECTION 7.02, THE NORTH KONA ZONE MAP, ORDINANCE NO. 63 (ZONING ORDINANCE), REVISED ORDINANCES OF THE COUNTY OF HAWAII 1967, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM SINGLE FAMILY RESIDENTIAL (RS-15) TO NEIGHBORHOOD COMMERCIAL (CN-10) AT KANAUEUE 2ND, NORTH KONA, HAWAII, COVERED BY TAX MAP KEY 7-9-13:4.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.02 of Ordinance No. 63 (Zoning Ordinance), Revised Ordinances of the County of Hawaii 1967, as amended, is hereby further amended by adding thereto the following subsection:

"7.02 (x). The district classification of the following area situated at Kanaueue 2nd, North Kona, Hawaii, shall be Neighborhood Commercial (CN-10):

Beginning at a pipe at the northwest corner of this parcel of land, at the south side of a 30-foot roadway and on the easterly side of a 60-foot wide Government Main Belt Road, the coordinates of said point of beginning referred to Government Survey Triangulation Station "PUU-O-HAU," being 3,092.49 feet north and 1,1275.37 feet east and running by azimuths measured clockwise from true south:

255<sup>0</sup> 191.41 feet along southerly side 58 ' 1. of a 30-foot roadway to a pipe; 2. 351° 90.31 feet along west side of a 001 25-foot wide road reserve to a pipe; 75<sup>9</sup> 186.07 feet along Lot 2 to a pipe; 3. 58 ' 90.00 feet along easterly side of 4. 167° 30" 36 ' a 60-foot wide Government Main Belt Road to the point of beginning and containing an area of 16,981 square feet or 0.390 acre.

"All as outlined in red on the map attached here, marked Exhibit "A" and by reference made a part hereof."

SECTION 2. Section 1 of this ordinance shall take effect forthwith upon the condition that the owner or lessee of the subject property be responsible for securing a building permit and commencing construction of the proposed apartment complex within one (1) year from the date of approval of the change of zone request. Should this condition not be met, the Planning Commission shall reserve the right to initiate action to rezone the subject property to its former designation.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.






