AN ORDINANCE AMENDING SECTION 7.06, THE NORTH AND SOUTH KOHALA DISTRICT ZONE MAP, ORDINANCE NO. 63 (ZONING ORDINANCE), REVISED ORDINANCES OF THE COUNTY OF HAWAII 1967, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM AGRICULTURAL (A-20a) TO AGRICULTURAL (A-1a) AT KAAUHUHU HOMESTEADS, SECOND SERIES, KAAUHUHU, NORTH KOHALA, HAWAII, COVERED BY TAX MAP KEY 5-5-13:17 AND 18.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.06 of Ordinance No. 63 (Zoning Ordinance), Revised Ordinances of the County of Hawaii 1967, as amended, is hereby further amended by adding thereto the following subsection:

"7.06(i). The district classification of the following area situated at Kaauhuhu Homesteads, Second Series, Kaauhuhu, North Kohala, Hawaii, shall be Agricultural (A-la):

Beginning at the northwest corner of this lot and also on the south boundary of a road easement, the coordinates of said point of beginning referred to Government Survey Triangulation Station "PUU O NALE" being 16,709.54 feet North and 4,286.61 feet East, thence running by azimuths measured clockwise from true South:

SECTION 2. Section 1 of this ordinance shall take effect forthwith upon the conditions that (A) the lowner or lessee of the subject area be responsible for securing preliminary approval of a subdivision plan within one (1) year from the date of approval of the change of zone; and (B) a minimum of two (2) dwellings be under construction within three (3) years of the date of approval of this request. Should this condition not be met, action may be taken to nullify any subdivision approval and to reclassify the subject area to a more appropriate designation.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.


