# ordinance no. 581

AN ORDINANCE AMENDING SECTION 7.12, THE HAMAKUA DISTRICT HOMESTEADS AREA ZONE MAP, ORDINANCE NO. 63 (ZONING ORDINANCE), REVISED ORDINANCES OF THE COUNTY OF HAWAII 1967, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM AGRICULTURAL (A-5a) TO AGRICULTURAL (A-1a) AT KAAO HOMESTEADS, HAMAKUA, HAWAII, COVERED BY TAX MAP KEY 4-5-03: PORTION OF 16.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.12 of Ordinance No. 63 (Zoning Ordinance), Revised Ordinances of the County of Hawaii 1967, as amended, is hereby further amended by adding thereto the following subsection:

"7.12(a). The district classification of the following area situated at Kaao Homesteads, Hamakua, Hawaii, shall be Agricultural (A-la):

Beginning at the north corner of this parcel of land at the west corner of Grant 8579 and on the east side of Pikake Street the coordinates of said point of beginning referred to Government Survey Triangulation Station "KAAO" being 2753.72 feet South and 221.74 feet West and running by azimuths measured clockwise from true South:

1.	294 <sup>0</sup>	58'	327.00	feet along Grant 8579;
2.	24 <sup>0</sup>	581		feet along remainder of Lot 41, Grant 9430;
3.	142°	36'	308.89	feet along Pikake Street;
4.	203 <sup>0</sup>	20'	425.40	feet along Pikake Street;
5.	195 <sup>0</sup>	57 <b>'</b>		feet along Pikake Street to the point of beginning and containing an area of 5.007 acres.

"All as outlined in red on the map attached hereto, marked Exhibit "A" and by reference made a part hereof."

SECTION 2. Section 1 of this ordinance shall take effect forthwith upon the conditions that (A) the owner or lessee of the subject area submit a subdivision plan for preliminary approval within one (1) year from the date of approval of the subject request; and (B) another dwelling be constructed on one of the lots within three (3) years. Should these conditions not be met, action may be taken to nullify any

subdivision approval and to reclassify the subject area to a more appropriate designation.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.






