AN ORDINANCE AMENDING SECTION 7.18, THE PUNA DISTRICT ZONE MAP, ARTICLE 2, CHAPTER 8 (ZONING CODE), HAWAII COUNTY CODE, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM OPEN (O) TO SINGLE FAMILY RESIDENTIAL (RS-15) AT KANIAHIKU VILLAGE, KANIAHIKU, PUNA, HAWAII, COVERED BY TAX MAP KEY 1-4-34.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.18 of Article 2, Chapter 8 (Zoning Code), Hawaii County Code, as amended, is hereby further amended by adding thereto the following subsection:

"7.18(e). The district classification of the following area situated at Kaniahiku Village, Kaniahiku, Puna, Hawaii, shall be Single Family Residential (RS-15):






