AN ORDINANCE AMENDING SECTION 7.18, PUNA DISTRICT ZONE MAP, OF CHAPTER 8 (ZONING CODE), ARTICLE 2, HAWAII COUNTY CODE, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM AGRICULTURAL (A-20a) TO SINGLE FAMILY RESIDENTIAL (RS-10) AT KEAAU, PUNA, HAWAII, COVERED BY TAX MAP KEY 1-6-02:27, 97 AND 1-6-03:27 (PORTION).

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.18 of Chapter 8 (Zoning Code), Article 2, Hawaii County Code, as amended, is hereby further amended by adding thereto the following subsection:

"7.18(f). The district classification of the following area situated at Keaau, Puna, Hawaii, shall be Single Family Residential (RS-10):

Beginning at a pipe at the northwest corner of this parcel of land and on the easterly side of old Volcano Road, the coordinates of said point of beginning referred to Government Survey Triangulation Station "OLAA" being 9109.68 feet North and 5872.81 feet East, and running by azimuths measured clockwise from true South:

1.	248°	40'		200.90	feet along remainder of Lot 1152-B-1 to a pipe;
2.	3 44°	05'	30"	190.86	feet along Lot 1156, Land Court Application 1053, Map 34, to the northerly side of Milo Street;

					Thence on a curve to the right with a radius of 81.64 feet along the northerly side of Milo Street to the east-terly side of old Volcano Road, the chord azimuth and distance being:
4.	116°	22'	45"	120.79	feet;
5.	164°	05'	30"	101.10	feet along the easterly side of old Volcano Road to the point of beginning and containing an area of 36,394 square feet.

SECTION 2. Section 1 of this ordinance shall take effect forthwith upon the condition that the applicant, W. H. Shipman, Ltd., submit a

subdivision plan and secure tentative approval within one (1) year of the date of approval of the change of zone.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.




