AN ORDINANCE AMENDING SECTION 7.29, THE CITY OF HILO ZONE MAP, OF CHAPTER 8 (ZONING CODE), ARTICLE 2, HAWAII COUNTY CODE, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM AGRICULTURAL (A-la) TO SINGLE FAMILY RESIDENTIAL (RS-15) AT KAUMANA, SOUTH HILO, HAWAII, COVERED BY TAX MAP KEY 2-5-55: 1 AND 2.

### BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.29 of Chapter 8 (Zoning Code), Article 2, Hawaii County Code, as amended, is hereby further amended by adding thereto the following subsection:

"7.29(s). The district classification of the following area situated at Kaumana, South Hilo, Hawaii, shall be Single Family Residential (RS-15):

Beginning at the southeast corner of this parcel of land, along the north boundary of Grant 4075 to Charles Auld being also along the west side of Malulani Drive, the coordinates of said point of beginning referred to Government Survey Triangulation Station "HALAI," being 13,661.42 feet South and 21,099.24 feet West and thence running by azimuths measured clockwise from true South:

1.	59°	5 <b>0'</b>	91.10	feet along Grant 4075 to Charles Auld;
2.	74°	26'	119.86	feet along Grant 4076 to Alexander Cockburn;
3.	164°	26'	243.06	feet along the remainder of Grant 8881 to George Lycurgus;
4.	268°	12'	301.16	feet along same;
5.	14°	05'	170.80	feet along the west side of Malulani Drive to the point of beginning and containing an area of 51,393 square

"All as outlined in red on the map attached hereto, marked Exhibit
'A' and by reference made a part hereof."

SECTION 2. Section 1 of this ordinance shall take effect forthwith upon the conditions that (A) the applicant, Lawrence Denis, submit a subdivision plan and secure tentative approval within one (1) year from the date

of approval of the change of zone; and (B) construction for another dwelling begin within one (1) year of receipt of final subdivision approval.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.






