AN ORDINANCE AMENDING SECTION 7.09, THE KAMUELA ZONE MAP, OF CHAPTER 8 (ZONING CODE), ARTICLE 2, HAWAII COUNTY CODE, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM AGRICULTURAL (A-5a) TO SINGLE FAMILY RESIDENTIAL (RS-15) AT PUUKAPU HOMESTEADS FIRST SERIES, PUUKAPU, WAIMEA, SOUTH KOHALA, HAWAII, COVERED BY TAX MAP KEY 6-4-01:PORTION OF 90.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.09 of Chapter 8 (Zoning Code), Article 2, Hawaii County Code, as amended, is hereby further amended by adding thereto the following subsection:

"7.09(g). The district classification of the following area situated at Puukapu Homesteads First Series, Puukapu, Waimea, South Kohala, Hawaii, shall be Single Family Residential (RS-15):

Beginning at the south corner of this parcel of land also being the northwest corner of a 25-foot roadway, the coordinates of said point of beginning referred to Government Survey Triangulation Station "WEST BASE," being 504.51 feet South and 186.92 feet East and running by azimuths measured clockwise from true South:

1.	149°	07'	206.80	feet along a portion of the northeast- erly boundaries of Grant 5184 and Grant 8961:1;
2.	239°	07'	50.00	feet along the southeasterly boundary of a cemetery lot;
3.	149°	07'	50.00	<pre>feet along the northeasterly boundary of a cemetery lot;</pre>
4.	59°	07'	35.00	feet along the northwesterly boundary of a cemetery lot;
5.	149°	07'	230.62	feet along the northeasterly boundary of a 15-foot roadway;
6.	229°	45'	129.08	feet along the southeasterly boundary of Government Land;
7.	329°	07'	536.70	feet along a portion of the southwest- erly boundary of Lot G of Puukapu Homesteads;
8.	70°	21'	145.14	feet along the north boundaries of

Lot F-3 and a 25-foot roadway to the

point of beginning and containing an area of 1.53 acres.

"All as outlined in red on the map attached hereto, marked Exhibit
'A' and by reference made a part hereof."

SECTION 2. Section 1 of this ordinance shall take effect forthwith upon the conditions that (A) the applicant, James Davis, submit a subdivision plan and secure tentative approval within one (1) year of the date of approval of the change of zone; and (B) another dwelling be constructed within two (2) years of final subdivision approval.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.






