SECTION 1. Section 7.19 of Chapter 8 (Zoning Code), Article 2, Hawaii County Code, as amended, is hereby further amended by adding thereto the following subsection:

"7.19(C). The district classification of the following area situated at Olaa Summer Lots, Olaa, Puna, Hawaii, shall be Village Commercial (CV-10):

Beginning at the east corner of this parcel of land at the north corner of Parcel 1 the coordinates of said point of beginning referred to Government Survey Triangulation Station "VOLCANO FLAG" being 50.14 feet north and 9193.78 feet east and running by azimuths measured clockwise from true South:

1.	59°	31'	134.15	feet along Parcel 1;
2.	149°	31'	15.00	feet along remainder of Parcel 2;
3.	239°	31'	134.15	feet along remainder of Parcel 2;
4.	329°	31'	15.00	feet along Lot 7, Grant 5684 to the point of beginning and containing an area of 2012 square feet.

"All as outlined in red on the map attached hereto, marked Exhibit 'A' and by reference made a part hereof."

SECTION 2. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 3. This ordinance shall take effect upon its approval.






