BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.29 of Chapter 8 (Zoning Code), Article 2, Hawaii County Code, as amended, is hereby further amended by adding thereto the following subsection:

"7.29(w). The district classification of the following area situated at Waiakea Homesteads Second Series, Waiakea, South Hilo, Hawaii, shall be Single Family Residential (RS-15):

Beginning at the southwest corner of this parcel of land and on the north side of drainage easement (15 feet wide) the coordinates of said point of beginning referred to Government Survey Triangulation station "HALAI" being 18,653.25 feet South and 912.69 feet West, and thence running by azimuths measured clockwise from true South:

1.	175°	40'	275.55	feet along Lot 61, portion of Grant 10417;
2.	265°	40'	179.56	feet along Lot 2, portion Lot 1002, Grant 10714;
3.	355°	40'	181.77	feet along Lot 4, portion of Grant 10417;
4.	61°	08'	100.19	feet along north side of drainage easement (15 feet wide);
5.	55°	07'	102.67	feet along north side of drainage easement (15 feet wide) to the point of beginning and containing an area of 0.930 acre.

"All as outlined in red on the map attached hereto, marked Exhibit 'A' and by reference made a part hereof."

SECTION 2. Section 1 of this ordinance shall take effect forthwith upon the condition that (A) the applicant, Haruo Murakami, submit a subdivision plan and secure tentative approval within one (1) year of the date of approval of the subject request; and (B) construction of another single family residential structure commence within three (3) years of receipt of final subdivison approval. Should any of the foregoing conditions not be met, rezoning of the property to its former zoning designation may be initiated.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.






