AN ORDINANCE AMENDING SECTION 7.29, THE CITY OF HILO ZONE MAP OF CHAPTER 8 (ZONING CODE), ARTICLE 2, HAWAII COUNTY CODE, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM AGRICULTURAL (A-3a) TO SINGLE FAMILY RESIDENTIAL (RS-15) AT WAIAKEA HOMESTEADS, 2ND SERIES, WAIAKEA, SOUTH HILO, HAWAII, COVERED BY TAX MAP KEY 2-4-37:10.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.29 of Chapter 8 (Zoning Code), Article 2, Hawaii County Code, as amended, is hereby further amended by adding thereto the following subsection:

"7.29(a). The district classification of the following area situated at Waiakea Homesteads, 2nd Series, Waiakea, South Hilo, Hawaii, shall be Single Family Residential (RS-15):

Beginning at the southeast corner of this lot, the southwest corner of lot 60, Camp 6 house lots extension, and on the north side of Ainaola Drive (50 feet wide), the coordinates of said point of beginning referred to Government Survey Triangulation Station "HALAI" being 18777.23 feet south and 1151.92 feet west, as shown on Government Survey Registered Map 2650, and running by azimuths measured clockwise from true South:

- 2. 103° 07' 50.00 feet along same;
- 3. 175° 40' 356.40 feet along Lot 1003, Waiakea Homesteads, 2nd Series, Grant 10543 to Shinkichi Higa;
- 4. 265° 40' 117.34 feet along same;
- 5. 355° 40' 381.16 feet along Lot 60, Camp 6 house lots extension to the point of beginning and containing an area of 1.00 acre, or thereabouts.

"All as outlined in red on the map attached hereto, marked Exhibit 'A' and by reference made a part hereof."

SECTION 2. Section 1 of this ordinance shall take effect forthwith upon the conditions that (A) the applicant, John D. Fernandez, submit a subdivision plan and secure tentative approval within one (1) year of the date of approval of the subject request; and (B) fifteen (15) feet along

Ainaola Drive be delineated and set aside for future road widening purposes. Should any of the foregoing conditions not be met, rezoning to its original zoning designation may be initiated.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.






