BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.29 of Chapter 8 (Zoning Code), Article 2, Hawaii County Code, as amended, is hereby further amended by adding thereto the following subsection:

"7.29(ff). The district classification of the following area situated at Waiakea, South Hilo, Hawaii, shall be Single Family Residential (RS-15):

Beginning at the southwest corner of this lot, the southeast corner of Lot 59, Camp 6 House Lots Extension, and on the north side of Road "A" (50 feet wide), the coordinates of said point of beginning referred to Government Survey Triangulation Station "HALAI" being 18,777.23 feet South and 1151.92 feet West, as shown on Government Survey Registered Map 2650, and running by azimuths measured clockwise from true South:

1.	175°	40'	381.16	feet along Lot 59, Camp 6 House Lots Extension;
2.	265°	40'	116.07	feet along Lot 1003, Waiakea Home- steads, 2nd Series (Grant 10543 to Shinkichi Higa);
3.	355°	40'	360.04	feet along Lot 61, Camp 6 House Lots Extension;
4.	69°	29'	90.46	<pre>feet along the north side of Road "A" (50 feet wide);</pre>
5.	93°	39'	29.48	feet along same to the point of beginning and containing an area

"All as outlined as red on the map attached hereto, marked Exhibit
'A' and by reference made a part hereof."

SECTION 2. Section 1 of this ordinance shall take effect forthwith upon the conditions that (A) the applicant, David Prudencio, Sr., submit a subdivision plan and secure tentative approval within one (1) year of

the date of approval of the subject request. The applicant shall also be responsible for securing final subdivision approval; (B) construction of another single-family dwelling commence within three (3) years of receipt of final subdivision approval; and (C) fifteen (15) feet along Ainaola Drive be delineated and set aside for future road widening purposes. Should any of the foregoing conditions not be met, rezoning to its original zoning designation may be initiated.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.






