ORDINANCE NO. 3 344

AN ORDINANCE AMENDING SECTION 7.22, THE PAHOA ZONE MAP OF CHAPTER 8 (ZONING CODE), ARTICLE 2, HAWAII COUNTY CODE, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM AGRICULTURAL (A-la) TO SINGLE FAMILY RESIDENTIAL (RS-10) AT KEONEPOKO HOMESTEADS, KEONEPOKO IKI, PUNA, HAWAII, COVERED BY TAX MAP KEY 1-5-07:3.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.22 of Chapter 8 (Zoning Code), Article 2, Hawaii County Code, as amended, is hereby further amended by adding thereto the following subsection:

"7.22(e). The district classification of the following area situated at Keonepoko Homesteads, Keonepoko Iki, Puna, Hawaii, shall be Single Family Residential (RS-10):

Beginning at the north corner of this lot, at a post and pile of stones, the coordinates of which point are 1156.8 feet South and 848.6 feet East of Pahoa Triangulation Station as shown on Government Survey Registered Map 2084, and running by azimuths measured clockwise from True South:

- 1. 323° 23' 362.4 feet along 30-foot roadway to post and stones;
- 2. 53° 00' 687.0 feet along Lot 1 to post and stones;
- 3. 160° 34' 384.0 feet along government land to post and stones;
- 4. 233° 23' 573.4 feet along 30-foot roadway to the point of beginning and containing an area of 5.2 acres.

"All as outlined in red on the map attached hereto, marked Exhibit 'A' and by reference made a part hereof."

SECTION 2. Section 1 of this ordinance shall take effective forthwith upon the conditions that (A) the area be zoned in two (2) increments. The first increment shall consist of a maximum of 3.2 acres and the second, the remaining area. The effective date of zoning for the second increment shall be after development has occurred on the first increment. Development is defined as building permits

issued for residential dwelling units and construction partially completed - partially completed in the sense of having roofs on a minimum of twenty-five (25) percent of the units for the entire area of 5.2 acres; (B) the applicant, Yet Kong Lum, submit a subdivision plan for the first increment and secure tentative approval within one (1) year from the official date of approval of the change of zone and also assume the responsibility of securing final subdivision approval for the first increment. The applicant shall also be responsible for obtaining final subdivision approval of the second increment; and (C) the applicant, Yet Kong Lum, provide a cash contribution of two hundred fifty dollars (\$250.00) per lot to the County of Hawaii, at the time of final subdivision approval for each zoning increment. Said funds shall be expended by the County to further the area's park and recreational development program. Should any of the foregoing conditions not be met, rezoning of the property to its original zoning designation may be initiated.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.






