AN ORDINANCE AMENDING SECTION 7.19 THE VOLCANO-MT. VIEW ZONE MAP OF CHAPTER 8 (ZONING CODE), ARTICLE 2, HAWAII COUNTY CODE, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM VILLAGE COMMERCIAL (CV-10) TO SINGLE FAMILY RESIDENTIAL (RS-10) AT MT. VIEW, PUNA, HAWAII, COVERED BY TAX MAP KEY 1-8-02:48.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.19 of the Chapter 8 (Zoning Code), Article 2, Hawaii County Code, as amended, is hereby further amended by adding thereto the following subsection:

"7.19 (). The district classification of the following area situated at Mt. View, Puna, Hawaii, shall be Single Family Residential (RS-10):

Beginning at the East corner of this parcel, the point being on the north edge of the Nichols Road right-of-way, the coordinates of said point of beginning referred to Government Survey Triangulation Station "OLAA" being 18516.12 feet South and 18974.23 feet West, thence running by azimuths measured clockwise from true South:

- 1. 66° 37' 118.00 feet along the north edge of the Nichols Road;
- 2. 156° 37' 85.00 feet in Lot 109, Grant 4053;
- 3. 246° 37' 118.00 feet in Lot 109, Grant 4053;
- 4. 336° 37' 85.00 feet in Lot 109, Grant 4053; to the point of beginning and containing an Area of 10,030 Square Feet.

"All as outlined in red on the map attached hereto, marked Exhibit 'A' and by reference made a part hereof."

SECTION 2. Section 1 of this ordinance shall take effect forthwith upon the condition that all applicable rules and regulations of the Single Family Residential - 10,000 square foot (RS-10) zoned district be complied with. Should this condition not be met, rezoning of the area to its original zoning designation may be initiated.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.






