COUNTY OF HAWAII - STATE OF HAWAII ORDINANCE NO. _385

AN ORDINANCE AMENDING ORDINANCE NO. 15 RELATING TO A CHANGE OF DISTRICT CLASSIFICATION FROM AGRICULTURAL (A-3a) TO AGRICULTURAL (A-1a) IN WAIAKEA HOMESTEADS, WAIAKEA, SOUTH HILO, HAWAII, COVERED BY TAX MAP KEY 2-4-04:30.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 2, Ordinance 15, is hereby amended so as to read in its entirety as follows:

"Section 2. Section 1 of this ordinance shall take effect forthwith upon the conditions that (A) the applicant, Hirosuke Akamine, submit and secure tentative approval of the proposed subdivision within one (1) year of the date of approval of the change of zone; (B) one (1) dwelling be constructed on the resultant lots within one (1) year of the date of final subdivision approval; and (C) a 5)-foot right-of-way, which would be a continuation of Akea Street, be set aside through the width of the proposed subdivision. Should any of the foregoing conditions not be met, rezoning of the area to its original or a more appropriate zoning designation may be initiated."

SECTION 2. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 3. This ordinance shall take effect upon its approval.
