ORDINANCE NO. 437

AN ORDINANCE AMENDING SECTION 7.06 THE NORTH AND SOUTH KOHALA DISTRICTS ZONE MAP, ARTICLE 2, CHAPTER 8 (ZONING CODE) OF THE HAWAII COUNTY CODE, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM AGRICULTURAL (A-20a) TO AGRICULTURAL (A-10a) AT KAAUHUHU, MAHUKONA 1ST AND NUNULUNUI, NORTH KOHALA, HAWAII, COVERED BY TAX MAP KEY 5-5-01:PORTION OF 5.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.06, Article 2, Chapter 8 (Zoning Code) of the Hawaii County Code, as amended, is hereby further amended by adding thereto the following subsection:

"7.06 (t). The district classification of the following area situated at Kasuhuhu, Mahukona 1st and Nunulunui, North Kohala, Hawaii, shall be Agricultural (A-10a):

Beginning at the West corner of this parcel of land on the Southeasterly side of Homestead Road, the coordinates of which referred to Government Survey Triangulation Station "PUU O NALE" being 741.07 feet South and 2,274.45 feet East and running by azimuths measured clockwise from true South:

1.	212 ⁰	25 '	37.40	feet	along the Southeasterly side of Homestead Road;

"All as outlined in red on the map attached hereto, marked Exhibit 'A' and by reference made a part hereof."

"This ordinance shall take effect forthwith upon the conditions that (A) the petitioner or his authorized representative shall submit a subdivision plan and secure tentative approval within one (1) year from the effective date of approval of the change of zone request. The petitioner/representative shall also be responsible for securing final subdivision approval; (B) a minimum of twenty-five percent (25%) of the proposed 10-acre lot shall be put into some form of agricultural activity within three (3) years from the date of approval of the subdivision request; and (C) all other applicable rules, regulations, and requirement shall be complied

with. Should any of the foregoing conditions not be met, rezoning of the area to its original or more appropriate zoning designation may be initiated."

SECTION 2. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 3. This ordinance shall take effect upon its approval.
