COUNTY OF HAWAII - STATE OF HAWAII ORDINANCE NO. 497

AN ORDINANCE AMENDING SECTION 7.29 THE CITY OF HILO ZONE MAP, ARTICLE 2, CHAPTER 8 (ZONING CODE) OF THE HAWAII COUNTY CODE, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM DOUBLE FAMILY RESIDENTIAL (RD-3.75) TO GENERAL COMMERCIAL (CG-20) AT WAIAKEA, SOUTH HILO, HAWAII, COVERED BY TAX MAP KEY 2-2-22:15.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.29, Article 2, Chapter 8 (Zoning Code) of the Hawaii County Code, as amended, is hereby further amended by adding thereto the following subsection:

"7.29 (www). The district classification of the following area situated at Waiakea, South Hilo, Hawaii, shall be General Commercial (CG-20):

Beginning at a pipe at the North corner of this lot, the West corner of Lot 4, Block 72, and on the South side of Lanihuli Street the coordinates of said point of beginning referred to Government Survey Triangulation Station "Halai" being 1914.45 feet South and 6369.88 feet East, as shown on Government Survey Registered Map No. 2705, and running by true azimuths:

1.	328 ⁰	10'	240.0	feet along Lot 4;
2.	58 ⁰	10'	171.68	feet along Lots 17 and 18;
3.	148°	10'	240.0	feet along Lot 7;
4.	238°	10'	171.68	feet along South side of Lanihuli Street to the point of beginning and containing an area of 41,203 Square Feet.

"All as outlined in red on the map attached hereto, marked Exhibit 'A' and by reference made a part hereof."

SECTION 2. Section 1 of this ordinance shall take effect forthwith upon the conditions that (A) the petitioners or their authorized representative shall submit plans for and secure final plan approval, including approval for the change of use, within one (1) year from the effective date of the change of zone; (B) the development shall include the required parking and shall be provided with no more than one (1) access point off Lanihuli Street, which may also consist of a separate one-way ingress and one-way egress system; and (C) all other rules, regulations and requirements shall be complied with. Should any of the foregoing conditions not be met, the rezoning of the subject property to its original or more appropriate zoning designation may be initiated by the Planning Director.

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 4. This ordinance shall take effect upon its approval.






